Here is our pick of key highlights for the months of January, February and March 2025:

LANDMARK DECISIONS ON WATER AND SANITATION SECURED AT THE 38TH AU ASSEMBLY SEETING THE STAGE FOR THE LAUNCH OF TAFRICA WATER VISION AND POLICY IN 2026

AMCOW secured landmark decisions on water and sanitation at the 38th Ordinary Session of the Assembly of the African Union held on February 15–16 in Addis Ababa, Ethiopia. The AMCOW Secretariat, with strong support from Member States and the AUC, advocated for the adopting "Assuring Sustainable Water Availability and Safe Sanitation Systems to Achieve the Goals of Agenda 2063" as the African Union Theme of the year 2026.

During the 38th Ordinary Session, the Assembly of the Heads of State and Government (HoSG) of the Union took decisions:

- a. Assembly/AU/Draft/Dec.10(XXXVIII)Rev.1 adopting "Assuring Sustainable Water Availability and Safe Sanitation Systems to Achieve the Goals of Agenda 2063" as the African Union Theme of the year 2026.
- b. Assembly/AU/Draft/Dec.31(XXXVIII)Rev.1 acknowledging the Republic of Zambia's leadership to host, on 27 29 May 2025, the third African Implementation and Partnership Conference on water and sanitation (PANAFCON-3).

The business of the Union to commemorate the water and sanitation theme will be launched at the 39th Ordinary Session of the Assembly in February 2026. The Summit will set the stage for consideration and adoption of an Africa Water Vision and Policy. The goal is to strengthen water security towards attainment of Africa's aspirations to expand economic opportunities; and curtail the factors underlying unemployment, migration, displacement and insecurity.

The PAPNAFCON-3 serves as a multi-level dialogue process to:

 a. assure broad and active stakeholder input into prioritisation of the technical proposals and

- articulation of the action framework of the post-2025 Africa Water Vision and Policy;
- assure high-level political ownership of the Vision
 and Policy and, in turn, active commitment to
 actualise it by among others placing emphasis on
 making a business case for the water and sanitation
 economy as an essential success factor of national
 fiscal policy; and,
- c. ensure that the post-2025 Africa Water Vision and policy is aligned to and is adopted as an implementation framework of Agenda 2063.

The Assembly further tasked the AMCOW Secretariat and the AUC to work with the leadership of the African Union Sectoral Ministerial Committee on Water and Sanitation to ensure vertical alignment of the action framework for the AU Theme for 2026 and the United Nations Water Conference of 2026. And, as such, contribute to the Conference's goal to speed up the implementation of Sustainable Development Goal (SDG) 6 on water and sanitation.

The AMCOW Secretariat will continue working with Member States, the AUC, and all stakeholders to translate these decisions into action to achieve water and sanitation goals in Africa.



COURTESY CALL ON HONOURABLE MINISTERS RESPONSIBLE FOR WATER AND SANITATION AFFAIRS ENGAGEMENT AND STAKEHOLDER MOBILISATION

These courtesy visits were essential to:

- Orient the Honourable Ministers on their roles and expectations as AMCOW Vice Presidents for the period 2025-2027.
- Commence preparations towards hosting statutory subregional meetings and consultations on the post 2025 Africa Water vision and policy
- c. Secure support and leadership in translating commitments into action for the post-2025 Africa water vision and policy.
- d. mobilise Member States to uphold the decision of the Executive Council of the African Union approving "Assuring Sustainable Water Availability and Safe Sanitation Systems to Achieve the Goals of Agenda 2063" as the African Union Theme of the year 2026;
- e. preparations for the 2025 statutory subregional meetings for Eastern and Northern Africa subregions;
- f. sharing plans for the 3rd African Implementation and Partnership Conference on water (PANAFCON-3); and

Matters related to ensuring AMCOW's financial sustainability were also addressed.

The Secretariat also convened joint planning sessions with the African Union Commission and the African Development Bank / Africa Water Facility. The main purpose of the meetings was to strengthen collaborative efforts towards raising the profile of water and sanitation in the Continent's development agenda.

AMCOW Appointed To Siwi Board And World Water Congress Scientific Committee

In recognition of its continental mandate and leadership in the water and sanitation sector, leading global organizations appointed AMCOW to prominent positions. The appointments are of strategic importance to AMCOW's global engagement. These key appointments include:

 Board of Directors, Stockholm International Water Institute (SIWI): AMCOW's Executive Secretary has been appointed to the Board of Directors of SIWI, a leading global organization in water resource

- management.
- International Scientific Committee, XIX IWRA World Water Congress: The Executive Secretary has also been appointed to the International Scientific Committee of the XIX IWRA World Water Congress, scheduled to take place in Marrakech, Morocco, from December 1–5, 2025.

These appointments provide AMCOW with invaluable opportunities to:

- a. Network and Collaborate: Engage with experts, practitioners, researchers, policymakers, civil society, and the private sector.
- b. Knowledge Sharing: Facilitate the exchange of cutting-edge knowledge and best practices in the water and sanitation sector.
- c. Partnership Building: Forge strategic partnerships to co-develop actionable strategies and solutions for addressing critical challenges in global water governance, security, and sustainability.

These appointments provide AMCOW with an opportunity to mobilizing input in the Post-2025 Africa Water Vision and Policy development. The Secretariat will leverage these global engagement opportunities to gather valuable insights into the formulation of the Post-2025 Africa Water Vision and Policy.

The appointments also provide an opportunity to champion the water and sanitation agenda at the global level, ensuring Africa's strategic priorities are effectively represented.



AMCOW SECRETARIAT COORDINATING THE DEVELOPMENT OF STRATEGIC OPERATIONAL PLAN (SOP) 2026–2030

AMCOW Secretariat is facilitating a participatory process to develop a Strategic Operational Plan (SOP) covering the period 2026–2030. This new SOP is a critical initiative aimed at strengthening AMCOW's operational effectiveness. The goal is to have the SOP ready for endorsement by the 14th AMCOW General Assembly, scheduled for September-October 2025.

The SOP will serve several key functions:

- Implementing strategy: The SOP 2026-2030 will be instrumental in translating the goals of the overarching AMCOW Strategy 2018-2030 into specific, actionable plans.
- Bridging to the Future: It will play a vital role during the transition towards the implementation of the post-2025 Africa Water Vision and Policy, ensuring alignment between existing initiatives and the future water and sanitation agenda.
- Guiding Vision: The development process supports the move towards a new Africa Water Vision and Policy focused on achieving inclusive and climateresilient water security for the continent.

The forthcoming SOP is expected to clearly define:

- a. High-level framework results to be achieved.
- b. Periodic milestones for tracking progress.
- c. Detailed work packages outlining activities.
- d. An indication of the necessary inputs and resources required.

The AMCOW Secretariat will ensure that the final SOP 2026-2030 effectively translates the long-term strategy into actionable steps that address the emerging needs of Member States.

AMCOW STRENGTHENS POLICY ENVIRONMENTS IN PURSUIT FOR SAFELY MANAGED SANITATION AND HYGIENE SERVICES FOR ALL

In an ongoing effort, AMCOW has reiterated its commitment to working collaboratively with Member States and partners to advance safely managed sanitation and hygiene services for all. AMCOW's commitment is anchored on robust policy frameworks and effective monitoring mechanisms to strengthen institutional arrangements and track progress against set targets. This pursuit is significant in the implementation of Council Decision GA/13/2023/CAI/3 concerning the African Sanitation Policy Guidelines (ASPGs) in Action Programme.

ASPGs in Action: Monitoring and Reporting Framework

The Secretariat has developed a comprehensive framework to monitor the utilisation and impact of the African Sanitation Policy Guidelines (ASPGs) within Member States. A crucial element of this framework will be regular situation assessments, providing valuable data on the ground to inform policy adjustments and track progress towards improved sanitation and hygiene.

Towards a Unified Sanitation Policy Assessment Tool for Enhanced Policy Effectiveness:

AMCOW has engaged a consulting firm to undertake the reconciliation of the African Sanitation Policy Assessment Tool (ASPAT) and the Policy Monitoring and Assessment Tool (PMAT). The objective is to streamline and enhance the assessment of sanitation and hygiene policy environments across the continent. This work will result in a single, comprehensive tool that will facilitate more efficient and effective situation assessments. From the month of April 2025, stakeholder consultations will be carried out virtually. The aim is to collate information from sector experts to enrich the tool toward reaching the desired quality. This unified tool will be presented at PANAFCON-3 to showcase its utility for comprehensive policy assessments, enabling better decision-making and ultimately leading to more impactful sanitation and hygiene policies



AUC AND AMCOW ARE LEADING THE POST-2025 AFRICA WATER VISION AND POLICY FORMULA-TION PROCESS

AMCOW under the overall leadership of the African Union Commission (AUC) has made significant progress in formulating the post-2025 Africa Water Vision and Policy. The post-2025 Africa Water Vision and Policy aims to address the continent's water challenges and contribute to Africa's sustainable development.

In response to the recommendations of the 5th Partner Coordination Platform (PCP) meeting, the AUC established a Reference Group. The Reference Group's mandate is to advise the AUC Commissioner for Agriculture, Rural Economy and Blue Economy on the fundamental principles and core tenets of the Water Vision and Policy beyond 2025.

At the technical level, a dedicated team of "Sherpas" has been appointed. Their role is to facilitate the activities required to formulate the detailed text of the Africa Water Vision and Policy. The Sherpas are coordinated by the AMCOW Secretariat and supported by AUC, African Development Bank (AfDB), and United Nations Economic Commission for Africa (UNECA).

In February, the Sherpas devoted their focus on preparing six thematic papers. These papers provide context, identify gaps, and propose practical strategies to guide the subregional consultations effectively. The papers articulated context, identify gaps, and propose practical strategies for consultation.

In March through to April 2025, AMCOW jointly with AUC embarked on subregional consultations to solicit input to contribute to the formulation of a post-2025 Africa Water Vision and Policy. Additional review and global perspectives will be sought at the PANAFCON 3 convened on 27 - 29 May, in Lusaka, Zambia.

AMCOW MAKING PROGRESS ON THE STRATEGIC PROGRAMME ON GROUNDWATER FOR WATER SECURITY AND RESILIENCE IN AFRICA

AMCOW has made significant progress in enhancing groundwater security and resilience across the African continent. A key development is the creation of a dedicated strategic programme focused on improving groundwater management. In response to the 13th Ordinary Session decision of the Executive Council (EXCO/13/2022/WDH/3) taken in 2022 in Windhoek, Namibia, AMCOW has developed a draft Strategic Programme on Groundwater for Water Security and Resilience in Africa. This discussion document lays the foundation for a coordinated and effective approach to groundwater governance and management on the continent.

The aim of the Strategic Programme is to create an enabling environment for responsible and effective groundwater governance, guided by the following four key strategic objectives:

Strengthening Policy and Institutions: Enhance

- policy, legal, and institutional frameworks for sustainable groundwater development and management.
- Building Human and Institutional Capacity: Support multi-level capacity development in groundwater management for water security and climate resilience.
- **Demonstrating Economic Value**: Build a business case highlighting the economic value and cross-sectoral benefits of structured investment in groundwater development and management.
- **Developing and Operationalizing Tools**: Develop and implement tools for awareness, evidence-based decision-making, and stakeholder buy-in.

The draft programme document outlines a set of priority actions under each of these strategic objectives, providing a clear roadmap for implementation.

The development of this draft programme benefited significantly from the contributions of **four dedicated task teams comprising groundwater experts**. These experts provided invaluable technical input and also played a crucial role in facilitating discussions during the ongoing Sub-Regional Consultations process, ensuring a broad range of perspectives were considered.

Going forward, the AMCOW Secretariat will consider various ongoing groundwater initiatives across the continent to ensure the Strategic Programme is complementary and builds upon existing efforts.

The Secretariat will further engage with Member States, Regional Economic Communities (RECs), and relevant regional institutions to gather additional input and foster collaboration towards the eventual implementation of the AMCOW Strategic Programme on Groundwater for Water Security and Resilience in Africa.



AMCOW LEVERAGE PARTNERSHIPS TO ADVANCE SECTOR INITIATIVES AT 22ND AFWASA CONGRESS IN KAMPALA

AMCOW Secretariat participated in the 22nd professionals and leaders to discuss African water and sanitation challenges, solutions, and future perspectives. The Congress provided a valuable platform for AMCOW to advance critical initiatives and engage with a wide range of stakeholders. The Secretariat shared information on the roadmap for formulating the upcoming Post-2025 Africa Water Vision and Policy, outlining the pathway towards this significant continental framework. AMCOW invited participants at the Congress to actively involve in shaping the long-term water and sanitation agenda

AMCOW engaged also stakeholders on the preparatory process for the 8th African Conference on Sanitation and Hygiene (AfricaSan8), with an aim to foster collaboration and gather input relevant to consolidating the processes for this major event.

The AfricaSan International Task Force (AITF) Coordination Meeting

On the margins of the Congress, AMCOW organized the first coordination meeting of the AfricaSan International Task Force (AITF). This crucial meeting provided participants with essential information on:

- a. The overall framework and planning for the AfricaSan8 conference.
- b. Timelines for developing the 4th edition of the AfricaSan Ngor report and updates related to the Ngor data collection at member states level.
- c. Tools for assessing sanitation policies and implementation plans.
- d. The AMCOW Youth and Gender Inclusion (YoGI) implementation roadmap.
- e. Various initiatives focused on promoting climateresilient sanitation services across Africa.

Going forward, the AMCOW Secretariat will continue engaging stakeholders towards formulating the Post-2025 Africa Water Vision and Policy and preparing for AfricaSan8.

2024 SHARM EL SHEIKH COMMITMENTS IMPLEMENTATION REPORT FINALIZED

The AMCOW Secretariat finalised the drafting of the 2024 Annual Report of the Commission on the Implementation of the July 2008 Assembly Declaration on the Sharm El Sheikh Commitments for Accelerating the Achievement of Water and Sanitation Goals in Africa Assembly Decision (Assembly/AU/ Decl.1 (XI)).

A total of 45 Member States contributed to the data used in the preparation of the 2024 Africa Water Sector and Sanitation Monitoring (WASSMO) Report. The report serves to provides situational analysis of the continent's progress against the AWV 2025 to informs the AU and AMCOW policy direction to realize the goal of providing a strategic framework for inclusive climate resilience and water security on the continent beyond 2025 within the AU Agenda 2063.

The reporting process underscores the **vital role of cross-sector coordination in ensuring data availability.**Strengthening institutionalized monitoring and reporting systems at the national level, including robust information management, is crucial in enhancing data reporting through the WASSMO system in future cycles.

Going forward, the AMCOW Secretariat will commence the development of the **2025 Annual Report** on the implementation of the Sharm El Sheikh Commitments, with a focus on ensuring its comprehensiveness.

AMCOW and the Sustainable Environment and Blue Economy Director at the African Union Commission undertaking all necessary processes to present the 2024 WASSMO report through the relevant organs of the African Union for consideration at the AU Summit.

SUBREGIONAL CONSULTATIONS TO DRIVE CONSENSUS ON POST-2025 AFRICA WATER VISION AND POLICY

AMCOW jointly with the AUC, AfDB and stakeholders convened a series of subregional consultations as part of contribution towards the formulation of the post-2025 Africa Water Vision and Policy.

AMCOW, in close collaboration with the African Union Commission, successfully convened sub-regional consultations during the month of March 2025:

- Week 1 (March 4-7): Dar Es Salaam, United Republic of Tanzania hosted the consultations for the Eastern Africa Subregion.
- Week 2 (March 18-20): Abuja, Federal Republic of Nigeria hosted participants F from the Western Africa Subregion.
- Week 3 (March 24-26): Harare, the Republic of Zimbabwe welcomed participants from the Southern Africa Subregion.

Subregional Consultations for Central and Northern Africa are expected to be concluded by 10 April 2025.

Subregional consultations are a key step in shaping the future of water management and sanitation in Africa. They help ensure that the post-2025 Africa Water Vision and Policy reflects the diverse needs and priorities of all stakeholders. This is in line with AMCOW Decision GA/13/2023/CAI/1 to gather broad and active input into the prioritisation of technical proposals and the articulation of the action framework for this vital document.

These subregional consultations were strategically designed to achieve several key objectives:

- a. Enhanced Stakeholder Engagement: To foster broader engagement with Member States, Regional Economic Communities (RECs), River Basin Organisations (RLBOs), Civil Society Organisations (CSOs), and other relevant stakeholders.
- Thematic Paper Review: To provide a platform for the thorough review and discussion of thematic papers developed to guide the post-2025 Vision and Policy.
- c. Regional Input Generation: To actively generate

- regional inputs and perspectives that will directly inform the drafting of the post-2025 Africa Water Vision and Policy.
- d. Agreement on Technical Proposals: To build consensus on prioritised technical proposals for the post-2025 Africa Water Vision and Policy, informed by the insights from the 2024 sector performance report.

The team of Sherpas, acting as invaluable resource persons, have been instrumental in facilitating these consultations and guiding the formulation of the Vision and Policy. Their expertise and in-depth analyses are providing critical support to the AUC, AMCOW, AfDB, and UNECA in this crucial undertaking.

HIGH-LEVEL ENGAGEMENT IN GHANA ON AFRICASAN8 PRPEARATIONS

The AMCOW Secretariat undertake a courtesy call on Hon Kenneth Gilbert Adjei, Ghana's Minister for Works, Housing and Water Resources. During this visit, the Secretariat:

- Congratulated the Minister on his appointment to lead Ghana's public works, housing and water resources.
- b. provided insights to the Minister about AMCOW's leadership organs and his role as a member of the AMCOW Governing Council.
- c. Held discussions regarding the AfricaSan8 conference, referencing the hosting agreement signed in 2023, which commits the Republic of Ghana to hosting the 2025 AfricaSan Conference.
- d. Provided a briefing on AMCOW's upcoming events, including the roadmap for the Post-2025 Africa Water Vision and Policy formulation and the Third Pan Africa Implementation and Partnership Conference (PANAFCON-3) in Lusaka, Zambia.

During the visit, the Republic of Ghana reiterated its commitment to hosting the AfricaSan8 Conference, in line with the Memorandum of Understanding (MoU) signed in 2023. The Secretariat led by Engr Kwabene Gyasi-Duku, Director, Public Works, Water and Housing and Dr Tony Tsekpetse, Principal Deputy Director, Environmental Health Analyst visited the Accra International Conference Centre (AICC) and tour the facilities designated to host the AfricaSan8 conference.

Going forward, the AMCOW Secretariat will continue its engagement with the Republic of Ghana and stakeholders to finalize the details for AfricaSan8, including confirmation of the conference dates and venue.

SENEGAL TAKES THE HELM OF AMCOW, PLEDGING TO STRENGTHEN AFRICA'S WATER AND SANITATION AGENDA

AMCOW officially welcomed the Republic of Senegal as its new President, marking an important transition in advancing Africa's water and sanitation goals. The Republic of Senegal assumed the presidency from the Arab Republic of Egypt on 3 March 2025, and will lead AMCOW for a two-year term until 2027.

Leadership Transition and Vision

The handover ceremony took place virtually during the 6th Extraordinary Session of the Executive Committee (EXCO) of the Governing Council. His Excellency Dr. Cheikh Tidiane Dieye, in his inaugural address as the President of AMCOW, reaffirmed Senegal's commitment to drive progress to achieve sector targets.



Senegal's presidency is expected to inject new impetus into AMCOW's mission to enhance cooperation, policy coordination, and advocacy to advance the water and sanitation agenda across Africa.

Key Priorities Under Senegal's Leadership

The express ambition of Senegal is to focus on the following strategic areas:

- Strengthening AMCOW Governance: Enhancing leadership, fostering stronger partnerships, and ensuring an effective Secretariat.
- Developing a Post-2025 Africa Water Vision and Policy: Placing water and sanitation at the core of Africa's development priorities.
- High-Level Advocacy: Mobilising the continental and global support and providing leadership to commemorate 2026 as the "Year of Water in Africa."
- A Unified African Position on Global Platforms: Ensuring Africa's voice is heard in major global forums, including COP30 and the UN 2026 Water Conference.

Recognition of Outgoing Leadership

Dr. Dieye appreciated his predecessor, Prof. Dr. Hani Sewilam, Minister for Water Resources and Irrigation of the Arab Republic of Egypt, for his leadership from 2023 to 2025.

In his remarks, Prof. Sewilam highlighted Senegal's unique opportunity to bridge continental and global water initiatives. He stated, "as Co-Chair of the UN 2026 Water Conference alongside the UAE, Senegal holds the responsibility of aligning Africa's water and sanitation agenda with global commitments."

AMCOW's Executive Secretary, Dr. Rashid Mbaziira, emphasised that this transition occurs at a crucial

moment, citing ongoing efforts to elevate water and sanitation as key levers to achieving the AU Agenda 2063.

Strengthening Africa's Water Future

Dr. Mbaziira noted that the process to formulate the Post-2025 Africa Water Vision and Policy has reached a critical phase, requiring:

- Broad and Inclusive Dialogue: to ensure stakeholder engagement at all levels.
- High-Level Political Commitment: to secure political leadership and buy-in towards finalisation of the post-2025 Africa Water Vision and Policy.
- Adoption of the Vision and Policy: Ensuring that the new Vision and Policy are presented for consideration and approval at the 39th Ordinary Session of the African Union in 2026.

AMCOW's leadership changes also extend to its Executive Committee and Technical Advisory Committee, with Senegal taking a leading role. Additionally, Egypt will now chair the Africa Water Facility (AWF) Governing Council, an AMCOW initiative hosted by the African Development Rank

Continental Collaboration

Hon. Eng. Collins Nzovu, Zambia's Minister for Water Development and Sanitation, assured Senegal of Zambia's support to implement AMCOW's priorities. He remarked, "we congratulate Senegal on assuming AMCOW's presidency and as Co-Chair of the UN Water 2026 Conference alongside the UAE. Zambia remains committed to supporting Africa's water and sanitation agenda." Zambia will host the Third African Implementation and Partnership Conference on Water (PANAFCON-3). PANAFCON-3, as a key milestone event in the post-2025 Africa Water Vision and Policy formulation process, will review the draft vision and policy.

Similarly, Hon. Jumaa H. Aweso, Tanzania's Minister for Water, emphasised the importance of finalising the Post-2025 Africa Water Vision and Policy, affirming Tanzania's commitment as a Vice President for Eastern Africa of AMCOW. "It is fitting that Senegal leads AMCOW as we work towards a new Africa Water Vision and Policy. Tanzania is fully committed to supporting this noble task," he stated.

Morocco's Minister for Water and Equipment, His Excellency Nizar Baraka, welcomed the leadership transition, reaffirming Morocco's dedication to regional cooperation. He stated, "The Kingdom of Morocco remains committed to strengthening water sector cooperation across Africa. We look forward to working with Senegal and all AMCOW members to achieve our shared goals." He also announced that Morocco will host subregional consultations on the post-2025 Africa Water Vision from April 8–10, 2025, in Rabat.

A Unified Approach for Africa's Water Agenda

As Senegal assumes leadership, AMCOW is poised to drive a coordinated and results-oriented approach to water and sanitation development. By leveraging high-level advocacy and fostering global partnerships, AMCOW aims to position Africa's water and sanitation

agenda at the forefront of assuring social transformation and economic development on the continent.
